**SFCC Girl's Summer
Developmental Basketball Program**

You are invited to participate in the SFCC Girl's Summer Basketball program to be held in the gymnasium at Spokane Falls Community College, 3410 W Fort George Wright Dr, Spokane, Washington, from June 2 to July 11, 2008. Varsity games will be scheduled from 5:00-10:00pm, M-TH. Purple Division games will be played M-TH from 3:00-5:00pm. No games for any league will be played on July 4.

About the Summer Basketball Program

This program is designed to give athletes of the Inland Northwest the opportunity to play basketball in an organized team situation with qualified referees in a supervised setting. Many young girls may not have the time or the finances to go away to basketball camps. The goal of the program is to fill that gap.

Competition

Teams will be seeded by age group, ability, and preference. Each team will be assigned to a regular league schedule, with a tournament to be held the last week of the program for the top four teams in each division. Call 533-3647 to see if there is room in a preferred league.

Divisions will be limited to 10 teams--first come, first served. Each team must have a minimum of eight players, with a maximum of 12 players. Teams are guaranteed at least nine games. We will offer five leagues this year. They are subject to change depending on enrollment.

Leagues will be offered as follows:

"A" Red	3A-2A HS Varsity	Monday & Wednesday
"B" White	1A-B HS Varsity	Tuesday & Thursday
"C" Blue	3A-2A JV	Monday & Wednesday
"D" Green	1A-B JV	Tuesday & Thursday
"E" Purple	8 th -9 th Grade	3-5 pm Monday thru Thursday

T-shirts are awarded to all participants in the program. First place teams in each division will receive additional awards.

Although we do not require teams to wear uniforms, it is helpful if you do organize some type of jersey with numbers on the back. If you have a sponsor, please advise the team name you wish to use, or we will use your school name. Teams not providing T-shirts must wear the pinnies we will provide.

We will not hold any spots without paid registrations.
